# The Most Frequently Read Articles of 2019

2019 was the 32nd year of print and 17th year of online publication of the *Journal of the American Board of Family Medicine (JABFM)*. Here we provide our annual report of articles published in 2019 that were of greatest interest to our readers.

Table 1 shows the 3 most frequently read articles by issue in 2019 from Volume 32. Once again, original research proves to be the most-read type of article. In Table 2, we provide the 20 most frequently read articles in 2019 from all volumes (Volume 1 to 32). Historically, clinical articles tend to be the most read.
